Making a Gift from an IRA

1. If you do not have checks to access your IRA account, use the IRA distribution forms provided by your IRA custodian and the attached sample letter to direct that a distribution be made to The Jewish Foundation for the Righteous (JFR) at the following address:

2. Use the attached cover letter to convey the IRA distribution form to your IRA custodian. The letter specifically requests that your IRA custodian:
 - a. Identify your IRA as the donor of record in connection with the transfer;
 - b. Copy you on the transmittal.
3. We recommend that in addition to faxing your disbursement instructions to your IRA custodian you also fax it to the JFR 212.727.9956 or email sstahl@jfr.org a copy of your IRA distribution form and your transmittal letter.
4. If you have checks for your IRA account or wire transfer privileges and wish to make sure that the contribution is treated as made in 2015, your mailing must be postmarked by December 31, 2015, or the wire initiated on or before December 31, 2015. The JFR's wire instructions are:
