IN 2022, THE JFR DISTRIBUTED MORE THAN \$700,000 USD IN DIRECT SUPPORT OF RESCUERS WHO LIVE IN 13 COUNTRIES. FUNDS ARE DISTRIBUTED THREE TIMES DURING THE YEAR FOR RESCUERS LIVING OUTSIDE THE UNITED STATES AND QUARTERLY FOR RESCUERS LIVING INSIDE THE U.S. FUNDS ARE DISTRIBUTED TO THE RESCUERS IN A SAFE AND EFFICIENT MANNER. PROCEDURES AND SAFEGUARDS ARE ALSO IN PLACE TO ENSURE THAT THE RESCUERS RECEIVING MONTHLY SUPPORT FROM THE JFR ARE STILL ALIVE. THE MAJORITY OF THE RESCUERS RECEIVING FINANCIAL ASSISTANCE LIVE IN EASTERN
